6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Use personal protective equipment. Ventilate the area. Refer to protective

Handling

Respiratory protection

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikly to be sufficient to control particulates and solvent vapour in all cases.
